SCO Grand Chief meets with INAC Minister Andy Scott

n Wednesday, September 14, 2005, Southern Grand Chief Chris Henderson had the opportunity to meet with the Federal Indian Affairs Minister Andy Scott along with Grand Chief Ron Evans of the Assembly of Manitoba Chiefs and Tribal Chief Arnold Ouskan of the Keewatin Tribal Council in Winnipeg.

Grand Chief Henderson addressed Minister Scott on some of the critical issues facing our Member Nations such as Treaty Entitlement Land implementation and Canada's complex and cumbersome Additions to Reserve Policy. Addressing housing was a top priority for the SCO, as well as the difficulties facing Indian farmers in accessing support for the various

federal and provincial agriculture programs.

In addition, the Grand Chief conveyed a message to Minister Scott on behalf of the five (5) Dakota Nations who are not signatory to any numbered Treaties in Manitoba. In the absence of a Treaty, these Dakota Nations are advancing their rights and issues based on 'Aboriginal title', similar to those First Nations in British Columbia. These Dakota Indian Bands are

recognized under the Indian Act and fall within this legislative regime. What the Dakota Nations are seeking is the same consideration and opportunity that is extended to the First Nations in B.C.: full recognition.

Despite not making any new pledges and commitments at this meeting, the Indian Affairs Minister promised that a new relationship between

Canada and the Indian Nations would be unfolding after the First Minister's Meeting with the national Aboriginal organizations this November.

AMM and SCO discuss municipal and First Nations relations

On Wednesday September 14, 2005, Grand Chief Henderson had the opportunity to meet with officials from the Association of Manitoba Municipalities at the SCO Winnipeg Sub-office.

The AMM represents the interests of municipalities in Manitoba and lobbies on their behalf.

Among the issues discussed between Grand Chief Henderson and the AMM's President, Mayor Ron Bell of the Town of Birtle, were municipal/Aboriginal relationships and TLE

agreements and compensation in Manitoba.

"This meeting was purely introductory and we discussed potential ways of how our two organizations could work together in the near future", stated Grand Chief Henderson.

One critical issue facing First Nations and municipalities is the implementation of TLE agreements and how these

two governments could work together in addressing their concerns throughout this complex process.

Future meetings between SCO and the AMM are being considered and planned.



n September 9, 2005, the Chiefs Finance Committee met for their quarterly meeting on the Brokenhead Ojibway Nation. The year end Audit was discussed and tabled pending further actions.

The Finance Committee shall consist of only one representative from each of the Tribal Council areas and one representative for all the Independent First Nations.

The Finance Committee shall function by quorum and any decisions or actions by any individual member of the Finance Committee shall be null and void and of no force or effect unless that individual is an authorized delegate of the Finance Committee.

Keeseekoowenin Ojibway First Nation Sharing Lodge

Keeseekoowenin Sharing Lodge is now established in Wasagaming's heritage firehall to share, preserve, educate and celebrate the culture and history of the Riding Mountain band. Arts, crafts and traditional celebrations with the Elders, youth, artists, researchers and community partners will make the Lodge a year-round working interpretive centre.

Today, the Keeseekoowenin Ojibway First Nation has three reserves: the main reserve is Keeseekoowenin Indian Reserve 61 which is located adjacent to the village of Elphinstone, Manitoba; the second reserve is the Clear Lake Indian Reserve 61A, on the shores of Clear Lake, in Riding Mountain National Park; and a third reserve called the Bottle Lake Indian Reserve 61B next to Bottle Lake or "Battle Lake", as it was originally known.
